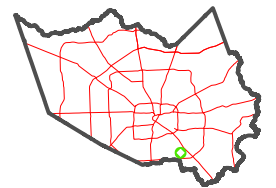

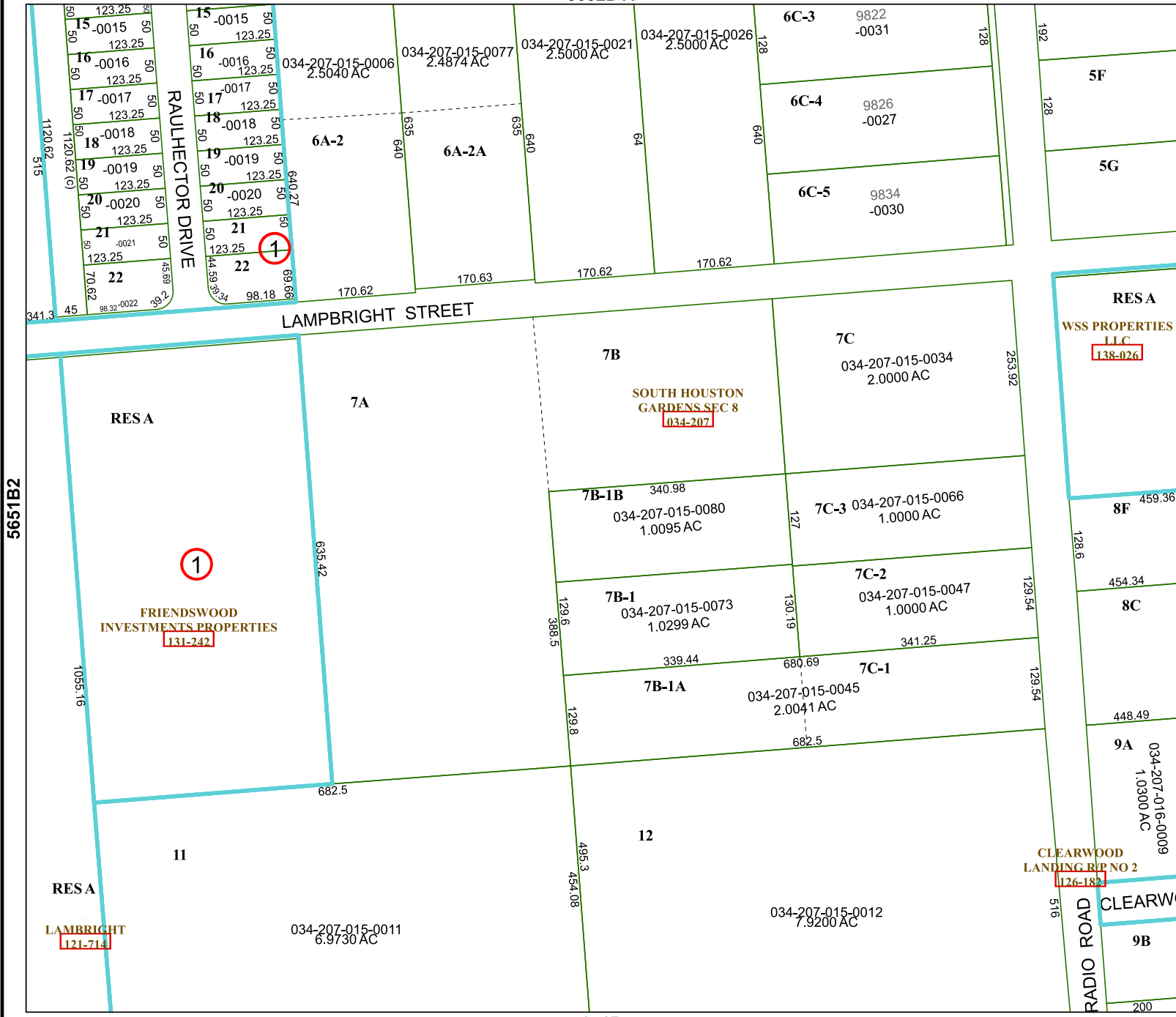


## MAP LOCATION
